

Tolosa Giveaway Official Rules

OFFICIAL RULES. The following are the official rules ("Rules") for all Tolosa Giveaways (each, the "Giveaway"). In order to enter the Giveaway, you must agree to these Rules. You agree that submission of an entry form and/or participation in the Giveaway constitutes your agreement to these Rules.

A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. Eligibility: The Giveaway is open only to legal residents of the contiguous forty-eight (48) states of the United States, Hawaii, Alaska, and the District of Columbia who are 21 years of age or older at the time of entry. Employees of Sponsor and its respective parent, affiliates, subsidiaries, Giveaway agencies, suppliers, are not eligible. Void in Rhode Island and Puerto Rico and where prohibited by law.
- 2. Sponsor: This Giveaway is sponsored by Tolosa Winery with its principal place of business at 4910 Edna Rd., San Luis Obispo, CA 93401.
- 3. Timing: The Giveaway period will be stated on the original photo post at the beginning of the giveaway and will include the end date and time 10/22/2021 11:59 pm (PST). ("Giveaway Period").
- 4. Entry: To enter the Giveaway, during the Giveaway Period, participants must: (1) Follow all participating accounts. A purchase or payment is not necessary; (2) Tag your friends on the post on @tolosawinery from during giveaway period. One (1) Winner will be randomly selected from the pool of Entries. Entrants must have a valid Instagram account to be eligible to enter. No more than one (1) person can enter using the same Instagram account. There is no limit on the number of entries an entrant may submit. Use of any automated system to participate is prohibited and will result in disqualification. The Giveaway is not sponsored by Instagram, Inc.
- 5. Selection of Winner: Sponsor will select One (1) Winner at random from the combined pool of Entries received during the Giveaway Period (the "Entries"). Odds of winning depend on the number of eligible Entries received during the applicable Giveaway Period. The Winner will be notified via direct message on Instagram within one (1) business day after the Giveaway Period ends. Entrants are responsible for checking their Instagram messages ensuring that their Instagram information is up-to-date and accurate. Prize notices returned as undeliverable will result in the disqualification of the potential prize Winner and an alternate Winner will be selected. Sponsor's decisions as to the random drawing are final and no correspondence will be entered. Winner will have twenty-four (24) hours to respond and claim their Prize via direct message from @tolosawinery. If the Winner is discovered to be invalid for any reason prior to delivery of the Prize, or if the Winner cannot be contacted or does not respond within the twentyfour (24)

hour time period, an alternate Winner may be selected, at the sole discretion of the Sponsor. If there is no Winner by the 30th day after end of Giveaway, no further Winners will be chosen. In the event of a dispute, the person to who the Instagram account used to enter the Giveaway was registered will be deemed the winning Entrant.

Potential Winner may be required to show proof of identification upon request in conjunction with Prize award/acceptance.

- 6. Prizes: Prizes will either be shipped or emailed to the Winner within one month of the Giveaway. No other Prizes will be awarded. Limit one (1) Prize per Winner. All results and decisions of Sponsor are final and binding in all respects. The Prize cannot be combined with any other offer. Prizes are non-transferable or redeemable in cash and must be accepted as awarded. Each Prize is awarded "as is" with no warranty or guarantee, either express or implied outside of manufacturer's limited warranty. No transfer, assignment or substitution of a Prize permitted. will have no liability whatsoever in connection with this Giveaway and, you shall hold them harmless for any injuries, losses or damages of any kind that you or others may incur as a consequence of your participation in the Giveaway or your acceptance, use or misuse of the prize. Sponsor is not responsible for any technical, network, electronic, computer, hardware and/or software malfunction, problem, incompatibility, congestion or failure of any kind. Sponsor reserves the right to cancel, terminate or modify the Giveaway at any time, in its sole discretion, if the Giveaway is not capable of completion as planned, including without limitation, the lack of Entry submissions, incomplete Entries, computer viruses, bugs, tampering, unauthorized intervention or technical failures of any sort, without notice. Upon cancellation or termination of the Giveaway for any reason, Sponsor shall have no obligation to award prizes or compensation of any kind.

By participating, you hereby release and hold harmless Instagram from any and all liability associated with this Giveaway.
